**Tuition rates and fees are set and are usually announced by Advisory Council at the time of registration. Tuition & fees include a \$200 building fee and an activity fee of \$220 PK-5th and \$325 6th-8th. There are no multiple children discounts for 2 and 3 day Pre-K and NC students. These fees are subject to change. Pre-K child-care credit should apply on income tax.

Additional fees may apply:

- Promotion Fee for Eighth Grade:** \$50.00 per student
- Sports Fee:** \$75 per child who participates.
- Volunteer Fee:** \$350 or 35 service hours per family
- Auction Fundraising Fee:** \$150 per family in form of payment or business services
- Yearbook Fee:** \$30 per family
- Technology Fee for students in grades 5-8:** \$50 per student

School Hours: K-8th – 8:00 a.m. to 3:05 p.m.; Pre-K – 8:00 a.m. to 2:55 p.m.

Registration forms for **Extended Day** will be mailed in July and available for pick up in the school office beginning August.

Tuition with fees is due in full on August 1 through the FACTS Tuition Management Program, or by signing up for the 10-month payout through FACTS. For the 10-month payout option, there is no interest fee charged, but a fee of \$75 per child, payable to ICCS, is due with the application. FACTS Tuition Management charges a \$50 per family for the 10-month payout, which is debited from your account. Please note: The \$50 fee debited from FACTS includes a \$5 fee to set up your incidental billing account. Payments are made directly to FACTS August through May using a bank draft.

Note: Families paying tuition in full through FACTS by August 1 will be required to sign up for tuition payment and incidental billing through FACTS for a one-time per year fee of \$20. If tuition is paid in full, the \$75 per child fee payable to ICCS will be waived. If paying with the 10-month payout option, you will be required to pay the \$75 fee per child to ICCS, plus the \$50 fee debited from FACTS directly. All fees are one time, annual fees.

To set up your FACTS account, visit our website at www.catholicschooldenton.org. Click on the Parents tab, then click on the FACTS ecashier logo.

It is the responsibility of the parents to notify the school administration of temporary financial difficulties.

All fees are non-refundable, and tuition will not be refunded unless relocating out of the DFW area. If refunded, a 10% withdrawal fee will apply.

Please note that **all fees must be current to re-register. If fees are not current, please arrange to meet with Mrs. Schad. Openings for next year will **not** be held pending payments for the current school year.

Method of payment: (MUST CHECK ONE)

Option 1: _____ One payment on August 1, through FACTS bank draft or credit card. Additional fees will apply through FACTS if paying by credit card. If tuition is paid in full, the \$75 fee per child payable to ICCS will be waived. You will be required to set up a tuition payment and incidental billing account through FACTS for a fee of \$20, which is debited directly by FACTS.

Option 2: _____ 10 month payout through FACTS (August-May) by bank draft or credit card. Additional fees will apply through FACTS if paying by credit card. A \$75 fee per child is due at registration, payable to ICCS. FACTS charges a \$50 per family fee per year that will be debited from your account (\$5 of this fee is for incidental billing).

Note: If you were enrolled for FACTS in 2018-2019, you will automatically be re-enrolled for 2019-2020.

***IMPORTANT: If you are changing your form of payment to credit card, you will need to edit your account and add the credit card number.**
